**ARTICLE I - NAME**

The name of this corporation is **FLORIDA HOME HEALTH AGENCY, INC.**, with its principal place of business located at 3850 SW 87 Avenue, Miami, Florida 33165 and the mailing address of the corporation shall be 8400 SW 133 Avenue, Apt. 207 Miami, Florida 33183.

**ARTICLE II - DURATION**

The corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The corporation purpose includes sales, services, and specialty in home health care, medical services agency and others to engage in any activities or business permitted under the Laws of the United States and of the state of Florida.

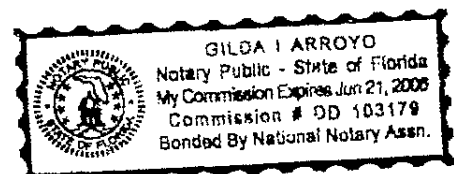
