The undersigned incorporator, ANTOINETTE K. CULLEN, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is AKC ENTERPRISES OF PENSACOLA, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 6310 Dunlieth Place, Pensacola, Florida 32504.

ARTICLE III - PURPOSE
