ARTICLES OF INCORPORATION
for

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Nick Baptista, P.A. Principal place of business is 4134 Alpina Court N., Boynton Beach, Florida 33436.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE
