
**ARTICLE VII



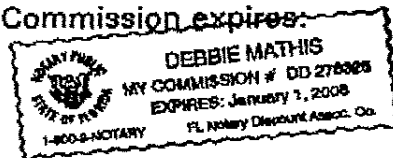
