
ARTICLE VII

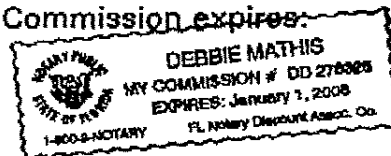
