ARTICLES OF INCORPORATION OF LET'S EAT INTELLECTUAL PROPERTY, INC.

The undersigned, acting as incorporator of Let's Eat Intellectual Property, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
