ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be
DOCTOR TILE RESTORATION 11 INC, and its principal office address is:

ARTICLE II. DURATION. This corporation is to exist perpetually.



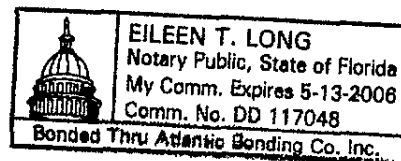
