**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
MC BUSINESS VENTURES, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, MC BUSINESS VENTURES, INC., a Florida corporation (the "Corporation") (Florida Registration #P05000035297), adopts the following amendments to its Articles of Incorporation:

1. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced by the following:

**"ARTICLE I  
NAME**

The name of the Corporation is **MDM BUSINESS VENTURES, INC.**"

2. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

The amendment was adopted by the Shareholders on June 9, 2010. The number of votes cast for the amendment by the Shareholders was sufficient for approval.
