The undersigned, Incorporator to these Articles of Incorporation, a natural person SEPTIONION competent to contract, hereby forms a Corporation under the Laws of the State Of Florida.

Article 1

The name of the Corporation shall be Jones Grading Inc.

Article 2

The principal place of business and mailing address of the Corporation is 6710 36th Avenue East, Lot 211, Palmetto, FL 34221.

Article 3

The maximum number of shares of stock that this Corporation is authorized to have outstanding is one thousand (1,000) shares of one class of stock with no par value.
