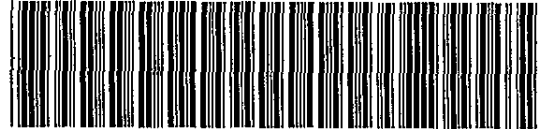


ARTICLE VII - AMENDMENTS
