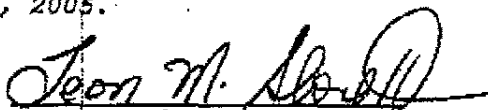
1. The name of the corporation is: **VKV Marketing Inc.**

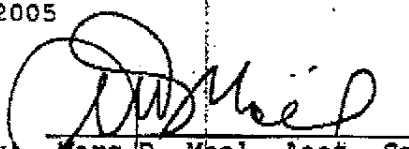
