### **A Florida Professional Corporation**

The undersigned incorporator to these Articles of Incorporation hereby associates to form a Florida professional corporation (the "Corporation") under Chapters 607 and 621 of the Florida Statutes.

#### 1. Name

The name of the Corporation is Dawn and Dyan, P.A. The Corporation's principal office (and mailing address) is located at 1730 SE 47th Terrace, Cape Coral, Florida 33904 in Lee County, Florida. The Board of Directors may from time to time move the principal office of the Corporation to any other address in the State of Florida.

#### 2. Nature of Business

The Corporation is formed to render professional services as a real estate sales associate, as defined in Chapter 475 of the Florida Statutes, and to engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

## 3. Powers

The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or in cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, desirable, suitable or proper for the furtherance, accomplishment, fostering or attainment of any or all of the purposes for which the Corporation is organized.
