The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida:

**Article I. Corporate Name.**

The name of this Corporation is:

**Article II. Mailing Address of Corporation.**

**Article III. Capital Stock.**

The aggregate number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Million (1,000,000) shares of common stock having a par value of \$.001 per share.
