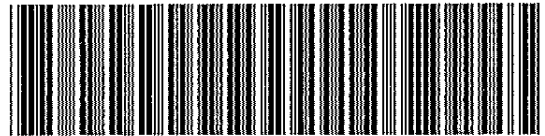

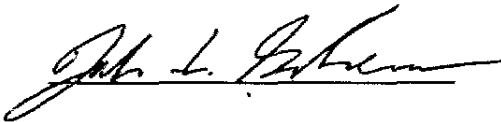
ARTICLE VIII - INDEMNIFICATION
