## ARTICLES OF INCORPORATION OF BLUE FLAME CORP.

#### Article I. Corporate Name

The name of this corporation is **BLUE FLAME CORP.**, and its principal place of business is to be located at, Juan J. Rodriguez, 139 N.E. 1<sup>st</sup> Street, Penthouse 16, Miami, FL 33130.

#### Article II. Nature of Business and Powers

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### Article III. Capital Structure
