ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - ADDRESS

The street address of the initial registered office of this corporation is 618 SW 26th Terrace, Cape Coral, Fl. 33914. The name of the initial registered agent of this corporation at the aforesaid street address is: Richard Bobo

ARTICLE III - NATURE OF BUSINESS
