

ARTICLE OF INCORPORATION TE&K INVESTMENT HOLDINGS COMPANY, INC. (10808 Oak Glen Circle, Orlando, FL 32817)

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Article of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II - TERMS OF EXISTENCE

The effective date upon which the Corporation shall come into existence shall be the date these ARTICLE OF INCORPORTION are filed with the Office of the Secretary of State, and it shall exist perpetually there after unless dissolved according to Florida Law.
