### ARTICLES OF INCORPORATION

#### **OF**

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

# ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is **HAUL IT AWAY**, **INC.** hereinafter referred to as the "Corporation".
