ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a corporation for profit under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation ("Corporation") is Signature Kitchens & Baths of Sarasota, Inc.
