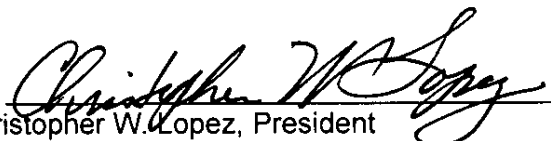
SECOND: The date of the adoption of these Articles of Dissolution is 18 November 2008.
