## ARTICLES OF INCORMPORATION OF NETPORTCAFES@, INC.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and hereby for a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME OF CORPORATION

The name of the corporation is NETPORTCAFES@, INC.

#### ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

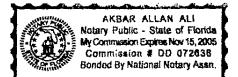
