ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ASMUSSEN-BROWN CONSTRUCTION, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, Asmuseen-Brown Construction, Inc., a Florida corporation, (the "Corporation") hereby adopts the following Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is Asmussen-Brown Construction, Inc. and the document number is P05000037605.
- 2. The following amendment to the Articles of Incorporation and First Amendment to the Articles of Incorporation was adopted by all of the members of the Board of Directors and Shareholders of record on March 10, 2005:

Article II - Capital Stock
