


ARTICLES OF INCORPORATION

<u>of</u>

BEVERLY HILLS PAINTING & HOME REPAIR, INC.

ARTICLE I. NAME

The name of this corporation shall be BEVERLY HILLS PAINTING & HOME REPAIR, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be when these articles are accepted for filing with the Florida Division of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of providing painting and general home repair services. The corporation shall be permitted to transact any and all business activities permitted under Chapter 607, Florida Statutes, and laws of the United States Of America.

ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 100 shares of no par value common capital stock.

ARTICLE V. PREEMPTIVE RIGHTS

Jacob Mulloy shall have the right to preemptively purchase for \$1.00 per share all the stock of the corporation during the life span of the corporation on 5 days notice to other stockholders.

ARTICLE VI. TRANSFER RESTRICTIONS

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this corporation, without first offering such shares for sale to this corporation at the price of \$1.00 per share. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at its registered office address, and open for acceptance by this corporation for a period of thirty days from the date of mailing. If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to dispose of such shares without any further restrictions.

On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and

this provision shall be binding upon the personal representative of the shareholder.

Each stock certificate issued by this corporation shall carry the following legend:

"These Shares Are Held Subject To Certain Transfer Restrictions Imposed By This Corporation's Articles Of Incorporation, A Copy Of Which Is On File At This Corporation's Principal Office."

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The number of directors on this corporation's initial Board of Directors shall be one. The number of directors may be increased or decreased from time to time, as provided in this corporation's bylaws, but shall never be less than one. The directors of the corporation shall be elected at the annual meeting of the shareholders and directors by majority vote.

Any director may be removed from office at any time with or without cause by the affirmative majority vote of the outstanding shares.

ARTICLE VIII. QUORUM AND MEETINGS

A quorum for the transaction of business at any meeting of the board of directors shall exist if fifty-one percent (51%) of the total number of directors shall be present at the meeting, in person or by proxy.

ARTICLE IX. INDEMNIFICATION

This corporation shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent, to the full extent permitted by law.

Any rights conferred upon the shareholders shall be subject to this reservation.
