

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Imagine Dot.com, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date these articles are filed.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK
