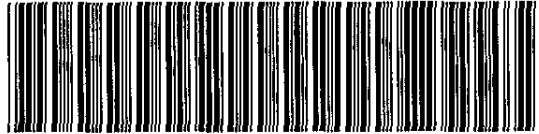

I


XIII



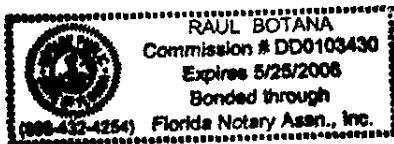


