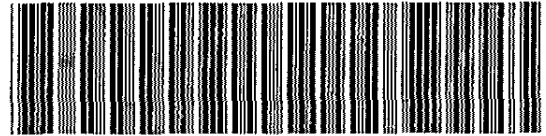

ARTICLE OF INCORPORATION
