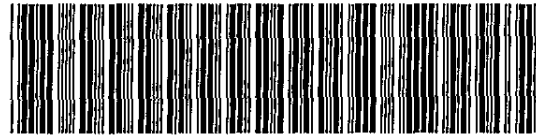

Name

Bylaws


