ARTICLES OF INCORPORATION

OF

CAREERLINX, INC.

The undersigned incorporator, subscriber to these Articles of Incorporation, being competent to contract, does hereby associate himself to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Careerlinx, Inc.

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is formed for the purpose of engaging in the business of staff leasing, but may engage in any lawful business for which corporations may be incorporated under the laws of the state of Florida.
