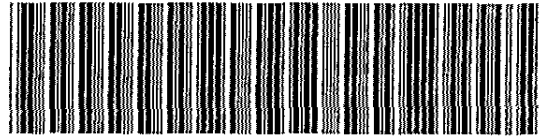

The undersigned subscriber, LINDA ATKINSON, a natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE. Name.

The name of the corporation is LINDA ATKINSON, P.A. The business address of the corporation is 24127 Buckingham Way, Port Charlotte, Florida 33980.

ARTICLE TWO. Duration

This corporation shall exist perpetually, except as provided by law. The corporation shall begin its existence on MARCH 1ST, 2005 at 12:01 a.m.

ARTICLE THREE. Corporate Purpose
