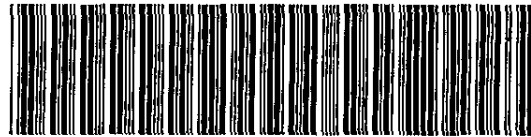

ARTICLE VIII

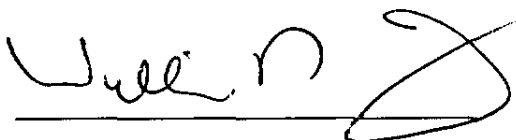

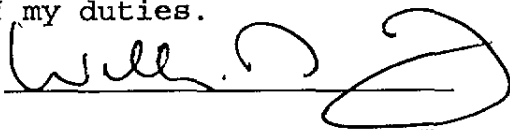
