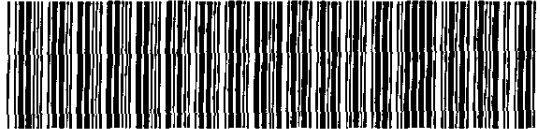

**ARTICLE I - NAME**

The name of this Corporation is KAMBRIE SHEA, INC., and the principal business and mailing address of the Corporation is 7700 Square Lake Boulevard, Jacksonville, Florida 32256.
