ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Bovine University, Inc.

ARTICLE II

The existence of the corporation shall begin on March 15, 2005.

ARTICLE III

The street address of the principal office of the Corporation is 112 Sequoyah Drive, Port Charlotte, Florida 33954.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares.
