The undersigned, acting as incorporator of THE CHAMPION COLLECTION, INC. under Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is THE CHAMPION COLLECTION, INC. (the "Corporation").

ARTICLE II. MAILING ADDRESS AND OFFICE

ARTICLE IX. AMENDMENTS

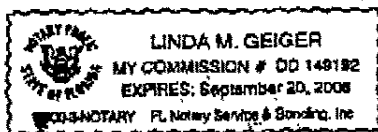


