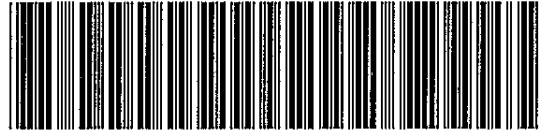



**ARTICLE I – NAME**

THE NAME OF THIS CORPORATION IS:

**ARTICLE II – DURATION**


