# ARTICLES OF INCORPORATION OF LAW OFFICE OF BRENDAN BRADLEY, P.A.

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### **ARTICLE I**

The name of the Corporation is: LAW OFFICE OF BRENDAN BRADLEY, P.A..

#### **ARTICLE II**

The street address of the principal office of the Corporation is: 1460 S. McCall Road, Suite 4-F, Englewood, FL 34223.

#### ARTICLE III

The specific purpose for which the Corporation is organized is: rendering professional legal services and shall have as its shareholders only other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed to render professional legal services in the State of Florida.
