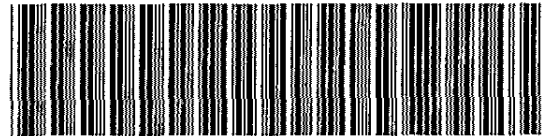

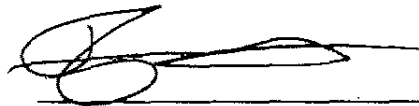
XIII

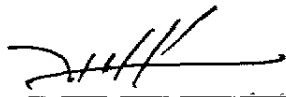

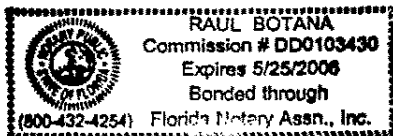

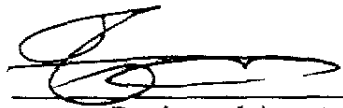
