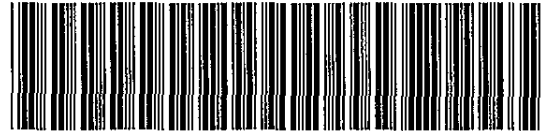


## ARTICLE IX – BY LAWS
