The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adapt the following Articles of Incorporation.

#### ARTICLE NO. I NAME

The name of this corporation shall be:

ARTICLE No. II TERM OF EXISTENCE
