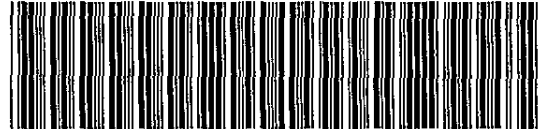



ARTICLES OF INCORPORATION

OF

GEORGE WILDER CARPENTRY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be GEORGE WILDER CARPENTRY, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE: The purpose is to engage in any activities or business permitted under the Laws of the United States and Florida; including but not limited to, residential and/or commercial carpentry.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.

ARTICLE FIVE: INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial registered office of the corporation is 2250 Elder Street, Bunnell, Florida 32110, and the name of the Registered Agent is GEORGE WILDER.

ARTICLE SIX: INITIAL BOARD OF DIRECTORS: This corporation shall have one (1) director initially. 


Pursuant to Chapters 48.091 and 607.0501, Florida Statutes, the following is submitted:
