



ARTICLES OF INCORPORATION

OF

PINOMAR CONSTRUCTION, INC.



ARTICLE I NAME

The name of the corporation is **PINOMAR CONSTRUCTION, INC.** The address of the corporation is 6617 N. THATCHER AVENUE, TAMPA, FLORIDA 33614.

ARTICLE II DURATION

The corporation shall have perpetual existence.

ARTICLE III PURPOSE
