Articles of Incorporation

of

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1: Name. The name of the Corporation is: CIRCLE R'S AGRIBUSINESS NETWORK, INC.

Article 2: Duration. The duration of the Corporation is perpetual.


