# ARTICLE I

# ARTICLE 11 DURATION

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

# ARTICLE III PURPOSE

The general purposes for which this Corporation is organized are the following:

- A. To engage in and transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act. No other purpose limits these general purposes in any way.
- B. To do such other things as are incidental to the purposes of this Corporation, or necessary or desirable in order to accomplish them.
