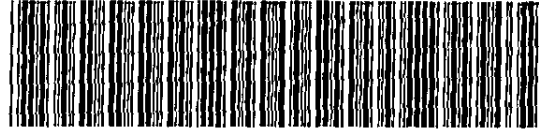

The undersigned incorporator hereby forms a corporation under chapter 607 the laws of the State of Florida.

ARTICLE 1- NAME
