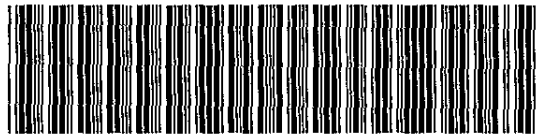


ARTICLE X. AMENDMENT
