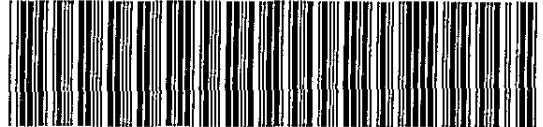

The undersigned incorporators, for the purpose of forming a corporation in compliance with Chapter 607 and /or Chapter 621, F.S. (Profit), hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

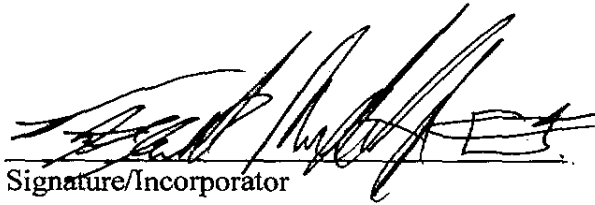

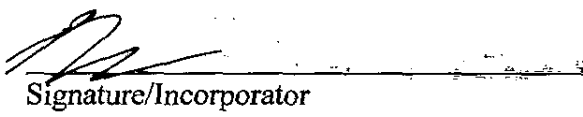
