## ARTICLES OF INCORPORATION OF PERFORMANCE, INC.

**(I)** 

The Name of the Corporation is Performance, Inc.

(II)

The Corporation is organized pursuant to the provisions of the Florida Business Corporations Act.

(III)

The period of its duration is perpetual.

(IV)

The Corporation is a corporation for profit and is organized for the following purposes:
