FOR

The undersigned incorporator(s), for the purpose of forming a corporation for profit under Chapter 621 of the Florida Statutes, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE 1  
NAME**

The name of the corporation shall be **PROSPECTIVE GRAPHICS, INC.** and these Articles of Incorporation as the "Articles," and the By-Laws of the Association as the "By-Laws."

**ARTICLE 2  
PRINCIPAL OFFICE**

The principal office and mailing address of the **PROSPECTIVE GRAPHICS, INC.** shall be 5914 S.W. 133<sup>RD</sup> Place, Miami, Florida 33183 or at such other place as may be subsequently designated by the Board of Directors. All books and records of the corporation shall be kept at its principal office or at such other place as may be permitted by the Act.


