ARTICLES OF INCORPORATION

'The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida; do hereby certify as follows:

ARTICLE I - NAME

The name of this corporation is: ALL IN ONE GROUP, INC.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by this corporation shall be:

- A) Primarily to engage in the landscape business and in general to perform any duties that may be related.
