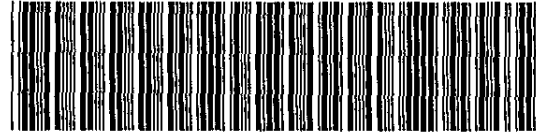

Article I
Identification

The name of the corporation, hereinafter referred to as the "Corporation," is Juarez Home Repair Inc.

Period of Existence

The period during which the corporation shall continue is perpetual.
