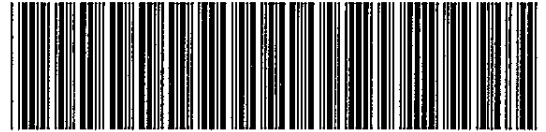



FIRST. The name of this corporation Florida Natural Life, Inc

SECOND. The registered office and principal office in the State Of Florida is to be located, 10740 Westwood Lake DR in the city of Miami, County of Dade. The registered agent in charge thereof is Yamile Gomez 10740 Westwood Lake DR, Miami FL 33165

THIRD. The nature of the business and, the objects and purposes proposed to be transacted, Promoted and carried on, are to do any or all the things herin mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world , viz:

With the consent in writing and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding the directors shall have the authority to dispose, in any manner of the whole property of this corporation.

The By-Laws shall determine whether and to what extent the accounts and books of this corporation, or any of them shall be open to the inspection of the stockholders; and no stockholder shall have any right of inspecting any account , or book or document of this corporation, except as conferred by the law or the By-Laws, or by resolution of the stockholders.



It is the intention that the objects, Purposes and powers specified in the third paragraph hereof shall, except where otherwise specified is said paragraph, be nowise limited or restricted by reference to or interference from the terms of any other clause or paragraph in his certificate of incorporation, but that the objects, purposes and powers specified in the third paragraph and in each of the clauses or paragraphs of this charter shall be regarded as independent objects, purposes and powers.
